The Consumer Confidence Report Is being completed to be mailed out in the July billing. The water level in wells Seems to be holding up well with the drought situation. If we had to, Well 3 could be brought on line (with some expenditure such as well house and other Items).

8. Fire Department

a. Update on Fire Department Activity

Tyson Rael is the new chief of the GVFD. He gave the report. The Wildand PPF is expired, as it is only good for 10 years from the manufactured Date. The Department is looking at getting a second driver qualified and is in the budget. He also passed out the CAVFA Grant Program information that the fire Department is going to work on applying for. Also they are checking into information on software that will allow us to have records the same as the rest of the fire departments in Plumas County. The department is looking into sending firefighters to the First Responder training. Currently there are 8 volunteers, with 5 to 6 people who respond on a regular basis. LifeFlight Training is planned as a future training. On 5/27 at Fireground hydraulics there were 3 trainees. On 6/1 there was the Wildand Interface Training (WIU) 6 trainees attended. On 6/10 there was a Wildland handlines and Fire Shelter

training with 3 attendees. And on 6/17 there was a medical training with 5 trainees. Vehicle 8325 is Out of Service and getting repairs. Vehicle 8322 will need repairs once 8325 is done. Quincy will loan us a wildland Engine while 8322 is Out of Service. Vehicle 8351 also needs repairs and is Out of Service. The Department responded to 4 calls. 1 vegetation at Camp Layman and OUR Department had it out before the Forest Service arrived. 3 medical calls which were all cancelled.

b. Fire Safe update

We now have the Final Draft. Tabled to July meeting. We will be having our Firewise Community day on July 26th. Janice and Gayle will be the committee

helping to get this all set up.
